Overview

Agromedicine is the systematic teamwork of land-grant and medical universities, in partnership with other agricultural, natural resources and health professionals, in the promotion of health and safety in agriculture, forestry, and fisheries. Agromedicine in North Carolina is administered through the NC Agromedicine Institute, which is a multi-disciplinary, multi-institutional partnership among East Carolina University, North Carolina A&T State University, and North Carolina State University. The collaboration involves research, prevention/intervention, and education/outreach by university members, Cooperative Extension, health educators, governmental, non-governmental, and agribusiness entities, among others.
